# 03. Qualifications:-

#### **External Candidates**

1. A Bachelor's Degree in Social science / Science / Business / Public Administration / Commerce / Management or Engineering which is recognized by the U.G.C.

AND

A minimum of **three-years** (03) post qualifying experience in the relevant field to the post after obtaining the first degree.

- 1. Having obtained the qualifications required by the external candidates as above.
- 2. Completion of minimum **three- years** (03) satisfactory service in a post in the Middle Manager (MM 1-1) Category, in the subject area relevant to the post

**01. Salary Scale: -** MM 1-1-2016

02. Age :-

Should be not less than 22 years and not more than 45 years to the date of 11<sup>th</sup> March 2024. (The upper age limit will not apply to the internal candidates.)

# 03. Qualifications:-

# External Candidates (1 or 2 below)

1. A Bachelor's Degree in Accountancy/ Commerce/ Finance/ Business Administration (special) in Accounting or Finance / Business Management (Accountancy /Finance) which is recognized by the U.G.C.

AND

A minimum of **one-year** (01) post qualifying experience in the relevant field to the Post, after obtaining the first degree.

2. Having passed the Intermediate Examination of a recognized professional Chartered Institute of which the subject area is relevant to the post and a minimum **one-year** (01) post qualifying experience in the relevant field to the post.

# **Internal Candidates:-**

Having obtained the qualifications required by the external candidates above.

## 04. Other Oualifications:-

Every applicant,

- i. Should be a citizen of Sri Lanka.
- Should be physically and mentally fit to discharge the duties of the post well and to serve in any part of the Island.
- iii. Should be of excellent moral character.

# 05. Recruitment Procedure:-

Appointments will be made in the order of merit in the structured interview conducted by a panel appointed by the authority after calling for applications. (In respect of every recruitment, provisions in the Scheme of Recruitment (SOR) shall apply.)

# 06. Nature of Appointment :-

These posts are permanent and entitled to Employees' Provident Fund and Employees' Trust Fund.
